The Bidding documents may be purchased by interested bidders on the submission of a written application to the address below at 8(b) and upon payment of a non-refundable fee of **UGX 100,000 (Uganda Shillings, One Hundred Thousand only)** for each. The method of payment will be **through the Uganda Heart Institute's Account Section on Block C Ward 2c New Mulago**
6. Bids must be delivered to the address below at 8(c) at or before **11:00am on 14th /10/2026**. All bids must be accompanied by a bid security as state above. Bid securities must be valid until **14th February 2027**. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at **11:30am on 14th October 2026**
